- 1. You ("Author") grant Dunton Publishing ("Publisher"), the right to include ("Essay") in the book tentatively entitled *Mystics in the City Part 2*. In so doing, the Author grants and transfers to the Publisher the following rights:
 - 1.1 Worldwide book rights—with the exception of Author reprinting their Essay on their own <u>personal</u> website or in a book comprised solely of the Author's original works, as long as it's stated, in each case, at the end of the Essay, "originally published in (tentatively titled) *Mystics in the City Part 2*."

All other rights (magazines, newspapers, online publications, audio, film, etc.) are at the sole discretion of Publisher on a case by case basis. (In other words, if it's something other than what's stated in the above paragraph, you need written permission from Publisher, with Publisher possibly receiving percentage of sale, depending on the situation.)

1.2 The right to reproduce, publish, distribute, and sell the Essay as an integral part of the Book in its entirety and alone or in part as an excerpt of the Book, as well as all subsequent revisions and editions thereof, in the English language and all other languages, throughout the world, in all forms of the book. This encompasses the original anthology format as well as all other book forms, including but not limited to adaptation, collected works, book club, digest, abridgement, condensation, Braille, large type, foreign—language, audio (recorded readings), visual projections, electronic and digitized (e.g., "e-books," interactive, multimedia versions, CD-ROM, screen—display technologies, verbatim text—only electronic editions, etc.), all mechanical reproduction and transcription (e.g., print-on-demand), films, and all "book" forms (written word) in any and all existing and forthcoming media and technologies. Author cannot receive a percentage of sale on Dunton

Publishing's ebook or any of the above mentioned related formats, containing your Essay.

- 1.3 All worldwide archival (data storage/retrieval) rights. The right to reproduce, publish, distribute, and sell —including to a third–party licensee—the Essay as an integral part of the Book in its entirety and alone or in part as an excerpt of the Book, in English and any other language, throughout the world, including but not limited to microfilm, microcard, online (Internet), CD–ROM, digitized, electronic, and any other information–storage/retrieval system.
- 1.4 Promotional use rights. The right to reproduce, publish, and distribute the Essay as an integral part of the Book in its entirety and alone or in part as an excerpt of the Book, in English and any other language, throughout the world, in any and all forms of promotional media, including live and recorded readings; print, electronic, and online catalogs; print, digitized, electronic, and online excerpts; radio, television, and print advertising and promotions; direct mailings; and all other marketing collateral.
- 2. The Author grants Dunton Publishing the right to use his/her name and biographical information in connection with the Book, including for promotion and advertising purposes. Dunton Publishing agrees to credit the Author with each published use of the Essay.
- 3. The Author grants Dunton Publishing the right to edit, condense, and/or alter the Essay, including its title, as necessary for publication. Dunton Publishing agrees not to change the facts of the Essay.
